Matthew Edward Gonzalez is an attorney, and a prominent figure in San Francisco politics. Gonzalez was a member and president of San Francisco County's Board of Supervisors. He was also one of the first Green Party candidates elected to public office in the San Francisco Bay area. In 2003, Gonzalez ran for mayor of San Francisco but lost in a close race to Democrat Gavin Newsom. Mr. Gonzalez is widely credited with promoting progressive values during the campaign. In the 2008 presidential election, Gonzalez ran for vice president as the running mate of candidate Ralph Nader.

Joseph P. Russoniello an American attorney who recently served as the U.S. Attorney for the Northern District of California after being appointed by President George W. Bush and confirmed by the United States Senate in 2007. Russoniello served his first term from 1982 to 1990 after being appointed by President Ronald Reagan and confirmed by the United States Senate. Mr. Russoniello was succeeded in August of 2010 by Melinda Haag as the U.S. Attorney for the Northern District of California (which encompasses the 15 counties from the Oregon-California border to Monterey, including the San Francisco Bay Area).Upon taking office, Mr. Russoniello indicated that his priorities during his second term would include national security, helping to get guns off the street and prosecuting Internet child pornography distribution. He is also overseeing his office's prosecution of Barry Bonds, former San Francisco Giants outfielder and all-time Major League Baseball home run king, on perjury charges, as well as Ed Jew, former Member of the San Francisco Board of Supervisors, on extortion and bribery charges.
